



Importing Personal Property Into

GRENADA

IMPORTING HOUSEHOLD GOODS & PERSONAL EFFECTS

DUTY-FREE ENTRY IS PERMITTED IF THE FOLLOWING REQUIREMENTS ARE MET:

- Your shipment consists of personal effects and household goods
- Items have been in shipper's possession for at least one year (for non-nationals)

Notes:

- The shipper is allowed importation of 1 quart or less of wine and spirits
- The shipper is allowed importation of ½ pound tobacco or 50 cigars or 200 cigarettes.
- Shipper must be present at time of customs clearance and must sign declaration of ownership in the presence of a customs official.

REQUIRED DOCUMENTS

- ✓ Inventory
- ✓ Invoices for new items
- ✓ Work permit
- ✓ Customs bond
- ✓ Bank guarantee
- ✓ Consularized certificate of origin
- ✓ Letter authorizing destination agent to clear shipment

IMPORTATION OF AUTOMOBILES

- Importation of cars up to 1600cc engine size allowed but heavily taxed.
- Taxes will be reduced by 50% if the shipper is a returning citizen of Grenada and has been living abroad for at least

seven years.

RESTRICTED AND PROHIBITED ITEMS

- Fruits and vegetable
- Soil
- Business Equipment
- Electronics
- Archeological Item
- Illegal Drugs
- Weapons & Ammunition

IMPORTATION OF PETS

- Permission for entry of dogs and cats must be obtained from the Ministry of Agriculture at the following address:

- An import permit should be presented to the Customs Department at the port of entry.

REQUIRED DOCUMENTS

- ✓ Import permit with the following information included: age, sex, color, breed, port of entry, time of arrival and airline name.
- ✓ Certificate verifying the dog or cat was vaccinated against rabies within six weeks prior to arrival in Grenada.
- ✓ Certificate of general health issued two weeks prior to arrival in Grenada
