



## Importing Personal Property Into

# SPAIN

### IMPORTING HOUSEHOLD GOODS AND PERSONAL EFFECTS

#### DUTY-FREE ENTRY IS PERMITTED IF THE FOLLOWING REQUIREMENTS ARE MET:

- The property has been in the possession and use of the shipper for at least 6 months (3 months for shippers from European Community countries).
- Property cannot be sold or transferred within one year of importation.
- Used household goods shipment must be imported no later than 12 months after the shipper has arrived.
- Returning nationals must have lived abroad for at least 1 year for duty-free entry.
- Foreign citizens must request a Special Visa from the Spanish Consulate in order to obtain the Residence Permit and Work Permit cards needed for customs clearance of items.

#### REQUIRED DOCUMENTS:

- ✓ Original passport of the shipper showing last entry stamped, or photocopy of same legalised by a Public Notary
- ✓ Detailed inventory in Spanish, valued, dated and signed, indicating make, model and serial number of major electrical appliances
- ✓ Residence Visa
- ✓ Work permit verifying employment eligibility in Spain (this process currently takes approximately 45-60 days to be completed).
- ✓ Application forms for duty-free importation signed by the shipper
- ✓ Ocean Bill of Lading or Air Waybill. Under marks, show name of shipper (consignee) and final destination point in Spain.
- ✓ It is recommended to hand-carry the purchase invoices for appliances

**Spanish Nationals:** Must have all documents listed above, plus the following:

- ✓ Original of De-registration certificate from the Spanish Consulate at origin. The stay abroad must have been for at least one year
- ✓ Fiscal identification card (N.I.F.)

**Foreign Citizens:** Must have all documents listed above, plus the following:

- ✓ Consular Document certifying registration in Spain
- ✓ Local City or consular Certificate of Departure obtained at Town hall, Police or similar legal authority at origin

**Note:** If moving to the Canary Islands or any of the other islands, additional documents may be required.

#### RESTRICTED/DUTIABLE ITEMS:

- New items, less than 6 months old
- Tobacco products
- Foodstuff, antiques, art objects and ammunition require a Special Permit

#### PROHIBITED ITEMS:

- Narcotics
- Firearms, automatic weapons, ammunition and explosives.

#### IMPORTATION OF MOTOR VEHICLES:

- Duty-free importation is granted for 6 months, if the shipper takes up residence in Spain and meets all other conditions
- Shipper must have resided abroad for at least 12 months
- The shipper must have used the vehicle for at least 6 months
- If modifications to the original design have been carried out on the vehicle, then importation is prohibited
- The shipper must obtain a Spanish Vehicle Registration.

## **IMPORTING MOTOR VEHICLES, PETS, ART, FIREARMS**

---

### **VEHICLES, REQUIRED DOCUMENTS:**

- ✓ Purchase invoice / Tax receipt
- ✓ Registration Title / Circulation permit
- ✓ Spanish Identification Card (D.N.I.) or Residence Permit Card
- ✓ Original Certificate of De-registration issued by the shipper's corresponding Consulate
- ✓ **Spanish/E.U. Nationals:**
  - ✓ Certificate of Departure obtained at Town Hall, Police or similar legal authority at origin
- ✓ Original Registration Certificate from the Town Hall of Spanish residency
- ✓ Application forms for duty-free importation signed by the shipper
- ✓ Engine seals and marks as well as chassis seals and marks must be taken physically from the car

### **IMPORTATION OF PETS:**

- Dogs and cats must be identified with a tattoo or microchip.
- Dogs and cats are permitted importation with no routine quarantine, but at the discretion of Customs, an animal may be kept for 40 days in quarantine.
- Pets must be vaccinated against rabies.
- Unaccompanied pets may be subject to duties and taxes; consult with the Customs post at point of importation for further details.
- Certain breeds of dogs are deemed potentially dangerous, and importation of these breeds requires fulfillment the abovementioned conditions, plus registration in the appropriate Municipal

Register and application for a special dog license. These breeds include:

- ✓ Pit Bull Terrier
- ✓ Rottweiler
- ✓ Akita
- ✓ Staffordshire Terrier

### **REQUIRED DOCUMENTS:**

- ✓ Vaccination and Health Certificate from veterinarian, consularized at origin, stating the animal has no contagious diseases.

### **IMPORTATION OF WORKS OF ART OR ANTIQUES:**

- Antiques and works of art may enter duty-free provided they form part of a household goods shipment, have been in the possession of the shipper for at least 6 months and are proportional for the social status of the shipper.

### **REQUIRED DOCUMENTS:**

- ✓ Special Permit

### **IMPORTATION OF FIREARMS**

- Rifles and shotguns for hunting purposes are permitted if the shipper obtains a Weapons License from Spanish authorities prior to importation. The process of obtaining such a license is generally a lengthy one.

### **REQUIRED DOCUMENTS:**

- ✓ Weapons License from Spanish authorities (Dirección General de la Guardia Civil).
