Importing Personal Property Into

BURKINA FASO

IMPORTING HOUSEHOLD GOODS/ PERSONAL EFFECTS, MOTOR VEHICLES AND WEAPONS

HOUSEHOLD GOODS/ PERSONAL EFFECTS WILL BE SUBJECT TO DUTY:

- There is no tax on personal effects as soon as the shipper has received exemption from the Customs head office.
- Non-diplomatic personnel receive dutyfree entry for personal effects for up to 6 months after arrival.

For Diplomats:

 Air/sea shipments will take 15 days to obtain the document for free entry from the Foreign Ministry and Customs Head Office.

REQUIRED DOCUMENTS

- ✓ Copy of passport with page of the visa.
- Detailed, valued and signed inventory in French. Inventory must be signed and dated by the shipper.
- ✓ Certificate of Change of Residence
- "Attestation Reservation de çale"
- Invoice of electrical items and furniture.
- Letter of transfer from the shipper's employer.
- Bill of lading with the price of freight indicated.
- Certificate of non-sale.
- Packing list

PROHIBITED/ DUTIABLE/ RESTRICTED ITEMS

- Alcohol and other spirits are prohibited and should be sent separately. Only "fond de cave" (less than 30 bottles) is acceptable. If the shipper wants to import more, there is a 6.5% tax on the declared value.
- Home computers are not accepted as personal effects and will be subject to customs duties and import taxes.
- New electrical items and furniture are subject to payment of customs duties and taxes.

IMPORTATION OF MOTOR VEHICLES

- New and used cars are dutiable.
- If a car is imported on a temporary importation, tax will be approximately 8.5%. All other vehicles tax will be approximately 62.16%. Taxes are based on the value of the car plus transport costs

IMPORTATION OF WEAPONS

 Importation of weapons and ammunition are submitted to authorization from territorial administration.

IMPORTATION OF PETS

- Pets may be imported into Burkina Faso and will be subject to a veterinary health examination upon arrival.
- All accompanying documents must be translated into French.

REQUIRED DOCUMENTS

- Health certificate stating that the pet is from a region declared to be unaffected for more than six weeks with any transmissible disease.
- International rabies vaccination certificate, dated more than one week and less than one year before arrival.
