

Importing Personal Property Into

Central African Republic

IMPORTING HOUSEHOLD GOODS AND PERSONAL EFFECTS

DUTY-FREE ENTRY IS PERMITTED IF THE FOLLOWING REQUIREMENTS ARE MET:

- Household goods must have been in the shipper's possession for at least 6 months.
- The goods must not be resold.

REQUIRED DOCUMENTS

- Packing list
- Detailed, valued, dated and signed inventory in French
- Resident or work permit or letter from the employer explaining that the client is starting a new contract
- Original rated Bill of Lading/Airway Bill
- ✓ Invoices for all electrical and "hi-fi" appliances and for all items bought less than 6 months prior to shipment's arrival
- Non-sale certificate (declaration that the client will not sell his HHG's)

TAX RATES ON CERTAIN HOUSEHOLD GOODS

If the shipper is not a diplomat:

- ► Tax on computers = 80% of CIF value + TCA (added tax of 16%)
- ► Tax on alcohol = 67.5% of CIF value + TCA (added tax of 16%)
- Tax on Tobacco = 77.5% of CIF value + TCA (added tax of 16%)
- ► Tax on electrical appliances=80% of CIF value + TCA (added tax of 16%)
- ► Tax on vehicle = from 48% to 78% of CIF value +TCA (added tax of 16%) (Tax varies based on value of vehicle.)

Note: No taxes are levied on cars for temporary admission

If the *shipper is a diplomat*, there is no tax, except for the following:

- ➤ Tax on computers (which are not considered personal effects and are never duty free) = 80% of CIF value + TCA (added value of 16%)
- ► Tax on vehicle =0.5% of CIF value

Please note that Customs only allows one of each type of appliance (i.e. one TV, one refrigerator etc.) per shipment; multiples will be taxed

All shipments are checked by Customs.

Additional Information:

- Invoice of all electrical items and furniture must be more than 6 months old. New electrical items are subject to payment of customs duties and taxes.
- Home computers are not accepted as personal effects and will be subject to customs duties and import taxes.

For diplomatic air/sea shipments, origin agent must send a copy of all original documents as soon as possible. It takes 15 days to obtain the document for free entry from the Foreign Ministry and Customs Head Office.

PROHIBITED/RESTRICTED ITEMS

- Guns and ammunition (must be submitted for authorization from territorial administration)
- Illegal drugs
- Alcohol and other spirits should be sent separately. Only the mention of "fond de cave" (fewer than 30 bottles) is acceptable.
- Dogs and cats: health certificate and rabies inoculation certificate (dated more than 1 month and less than 1 year before arrival) are required.
- Birds: a health certificate (dated less than 5 days before the arrival) is required. Parrots from the Americas are not allowed.

IMPORTING MOTOR VEHICLES

Documents required for used cars:

- Original registration card
- ✓ Copy of shipper's driving license
- Original invoice of the car
- Customs form F4

Documents required for new cars:

- Export declaration
- Copy of shipper's driving license
- Original invoice of the car
- Customs form F4

Note:

Documents must be received by the destination agent 1 month prior to shipment's arrival to avoid long delays and demurrage and storage charges.
