

# Importing Personal Property Into FINLAND

#### IMPORTING HOUSEHOLD GOODS AND PERSONAL EFFECTS

## DUTY-FREE ENTRY IS PERMITTED IF THE FOLLOWING REQUIREMENTS ARE MET:

- If imported from a European Union (EU) country:
  - Duty-free and tax-free entry is permitted except for prohibitions referred to in Article 36 in the Treaty of Rome.
- If imported from a non-EU country:
  - Goods have been used by the shipper and his/her family members abroad.
  - Shipper has lived abroad for at least 12 months.

#### Notes:

- The quantity of the goods must be of a reasonable amount.
- New household goods are subject to customs duties and tax.
- New immigrants who are moving from a non-EU country must have established a place of residence in Finland prior to Customs clearance.
- Returning citizens must have lived abroad for a minimum of one year.

#### **REQUIRED DOCUMENTS**

- For goods imported from an EU country:Inventory of goods
- For goods imported from a non-EU country:
  - Inventory in Finnish, Swedish, English or German, of the goods with exact number of packages.
  - ✓ Import Declaration (Customs Form 45)
- Copy of Passport
- Proof of employment
- ✓ New furniture requires:
  - Sales invoice with prices, dates and place of purchase.
  - ✓ Separate packing list.
  - ✓ Must be declared separately on Customs Form 45.

#### **DIPLOMATIC SHIPMENTS**

Duty-free entry will be granted.

## REQUIRED DOCUMENTS FOR DIPLOMATS

- ✓ Inventory of the goods.
- Obligation for privilege to be lodged by the Foreign Ministry.

#### **RESTRICTED/DUTIBALE ITEMS**

- Firearms are only allowed entry when accompanied by a Finnish License. If the license is not available at the time of import, the firearm will be taken by Customs and released only after receipt of the Finnish License.
- Alcoholic beverages are subject to high duties and extra customs clearance charges. For more than 5 liters, a special permit for importation must be obtained from the Alcoholic Monopoly. Boxes containing alcoholic beverages must be clearly marked and noted on the inventory.
- Tobacco and tobacco products are subject to customs duty and VAT.
- Plants and vegetable products require a phytosanitary certificate.
- Walkie-talkies and radios.

#### **PROHIBITED ITEMS**

- Explosives and fireworks
- Pornographic materials
- Skins, hides or tusks from animals under protected species regulation.
- Narcotics
- Clasp knives and automatic weapons

#### **IMPORTATION OF MOTOR VEHICLES**

 Automobiles and motorcycles are allowed duty-free entry if the shipper has lived abroad for at least one year prior to importation. It is also required that the

#### **IMPORTING MOTOR VEHICLES, PETS AND ART**

- shipper or the shipper's spouse have used the vehicle abroad for at least 6 months.
- Vehicle tax may apply to vehicles imported from either another EU country or a non-EU country. If tax exemption is not obtained, the taxes will be assessed at 50-60% of the retail price of a similar automobile in Finland.
- The automobile cannot be sold or otherwise disposed of for 2 years after importation.
- The automobile must conform to U.S. or European exhaust regulations.
- Only one vehicle per person is permitted.
- Trailers, caravans, boats, mopeds, snowmobiles, airplanes and other vehicles are duty-free if the vehicle has been used by the shipper or the shipper's family abroad for at least 6 months.

#### **REQUIRED DOCUMENTS**

- Customs Form 53.
- Documentation of length of stay abroad, such as a certificate provided by the employer.
- Certificate of registration
- Sales invoice with price, date and place of purchase
- ✓ Valid passport
- ✓ Traffic insurance policy valid in Finland.
- ✓ Driver's license

#### **IMPORTATION OF PETS**

- Pets are duty-free if proof of ownership if available.
- Only dogs, cats and birds are permitted.
- Pets are subject to 3 months quarantine.
- Veterinarian inspection at port of entry required for all animals except cats and dogs.
- Cats and dogs must have valid vaccination against rabies.

#### **REQUIRED DOCUMENTS**

- ✓ Health certificate
- ✓ Import permit from Ministry of Agriculture

### IMPORTATION OF WORKS OF ART OR ANTIQUES

- Duty-free entry is permitted if part of a household goods shipment or if the items are more than 100 years old.
- If the antiques or works of art are imported for re-sale, then different regulations apply.

#### REQUIRED DOCUMENTS

Inventory of the goods.
