Importing Personal Property Into

GHANA

IMPORTING HOUSEHOLD GOODS AND PERSONAL EFFECTS

DUTY-FREE ENTRY IS PERMITTED IF THE FOLLOWING REQUIREMENTS ARE MET

- Shipper is a diplomat
- Shipper has lived abroad for at least one year and did not return to Ghana during that time.
- Furniture and personal possessions have been in the shipper's possession for at least 6 months.
- Food and detergents are limited to a three month supply

REQUIRED DOCUMENTS

- ✓ Original Passport
- ✓ Original Bill of Lading/AWB
- ✓ Original Inventory in English dated, valued and signed by shipper
- ✓ Ghana Customs form C.12
- PUBD form ("personal unaccompanied baggage declaration") to be filled in at airport of arrival. Failure to do so results in a heavy penalty and long delay at customs.
- ✓ Invoices for all electrical and hi fi appliances and for all items bought less than 6 months before the shipment's arrival

Note:

- Only one electrical appliance of each type is allowed duty free. Duties will have to be paid on all others.
- Duties will have to be paid on all computer equipment.

RESTRICTED/PROHIBITED ITEMS

- Narcotics
- Arms and ammunition (permit required)
- Foreign cigarettes without warning notice

- Toxic waste and contaminated goods
- Mercuric medicated soap
- Animals, plants and seeds that are infected with any disease
- Foreign soil
- Pornography, defamatory, obscene and similar articles or publications
- Dangerous weapons
- Alcohol and Spirits (max. 10 bottles allowed, duties to be paid on excess)

IMPORTING MOTOR VEHICLES

- Shipper's presence may be required at Customs
- Vehicles over 10 years old are not allowed for importation
- Steering wheel must be on left side of vehicle

REQUIRED DOCUMENTS

- Original Registration Card
- Purchase Invoice
- Certificate of Ownership
- OBL showing chassis number, engine number, cylindrical power, age, make and model.

IMPORTING PETS

 Check with Ghana Customs and Dept. of Agriculture before shipping any animals. Import license is granted after the shipper has made arrangements for the period of quarantine with a licensed kennel.

REQUIRED DOCUMENTS

Proof of inoculation from a registered veterinarian
